

Notice of a Proposed Change to an Approved Renewable Energy Project

Project Name: Grand Bend Wind Farm
OPA Reference Number: FIT Contract #: F-002178-WIN-130-601

Project Location: North of Grand Bend, in the Municipalities of Bluewater and South Huron, in Huron County. Portions of the transmission system also traverse the Municipality of Huron East in the County of Huron and Municipality of West Perth, in the County of Perth.

Dated at: West Perth, South Huron, Bluewater and Huron East this 10th of November, 2014

Grand Bend Wind Limited Partnership, with Northland Power Inc. as agent, was issued a Renewable Energy Approval on June 26, 2014 in respect of the Grand Bend Wind Farm. Information with respect to the decision on this project can be viewed on the Environmental Registry by searching 011-9928.

Grand Bend Wind Limited Partnership, with Northland Power Inc. as agent, is proposing to make a change to the project and the project itself is subject to the provisions of the *Environmental Protection Act (Act)* Part V.0.1 and Ontario Regulation 359/09 (Regulation). This notice must be distributed in accordance with section 32.2. of the Regulation. This notice is being distributed to make the public aware of proposed minor changes to the project.

Project Description and Proposed Change: Pursuant to the Act and Regulation, the project in respect of which the Renewable Energy Approval was issued, is a Class 4 Wind Energy Facility.

An application has been made to the Ministry of the Environment to change the project and alter the terms and conditions of the existing Renewable Energy Approval. The application requests two minor amendments, as follows:

1. Changes to the temporary water takings and returns (which are short term ditch diversions during construction) estimated for the construction stage of the Project.
2. Alternative method of access road construction (road base materials) proposed by the contractor.

The total nameplate capacity (100 MW) of this project is not altered by this request. The project location is illustrated in the map below and is likewise unchanged by this request.

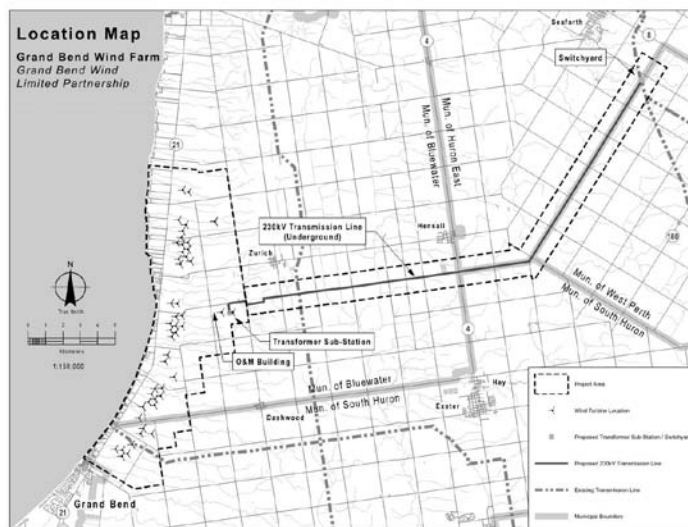
