NOTICE OF APPLICATION AND WRITTEN HEARING

APPLICATION FOR LEAVE TO CONSTRUCT A TRANSMISSION LINE AND RELATED FACILITIES FOR

- NORTHLAND POWER SOLAR EMPIRE L.P.
- NORTHLAND POWER SOLAR MARTIN'S MEADOWS L.P.
- NORTHLAND POWER SOLAR ABITIBI L.P.
- NORTHLAND POWER SOLAR LONG LAKE L.P.

Northland Power Solar Empire L.P., Northland Power Solar Martin's Meadows L.P., Northland Power Solar Abitibi L.P., and Northland Power Solar Long Lake L.P (collectively the "Applicant" or "Applicants") has filed an application with the Board, dated February 12, 2013, under sections 92 and 96(2) of the *Ontario Energy Board Act*, 1998, S.O. 1998, c.15, Schedule B. The Applicants general partners are Northland Power Solar Empire GP Inc., Northland Power Solar Martin's Meadows GP Inc., Northland Power Solar Abitibi GP Inc., and Northland Power Solar Long Lake GP Inc., respectively, each general partner being a wholly owned subsidiary of Northland Power Inc. ("NPI"). NPI and Northland Power Limited Partner Holdings Inc. are the limited partners, holding 99.9% and 0.1% limited partner interest, respectively, in each of the Applicants.

The Applicants are in the business of developing, constructing, owning and operating renewable generation projects and related transmission facilities. The Applicants have entered into contracts with the Ontario Power Authority and are in the process of developing 40 MW of solar power generating facilities located in the vicinity of the Town of Cochrane

The Applicants have a co-ownership agreement in place for the transmission line and associated facilities, including approximately 22 kilometres of 115 kilovolt ("kV") aboveground transmission line, 500 metres of underground transmission cable, 2 115 kV

transformer substations, a transition station, and a switching station (the "Transmission Facilities"), all to connect the generation sites via a single connection point, to the IESO-controlled grid. The Transmission Facilities will be entirely paid for by the Applicants.

The scope of this proceeding is limited to approving the construction of the Transmission Facilities. The consideration of any aspect of the proposed solar generation facilities is not within the Board's jurisdiction.

The work which is the subject of this application involves the construction of:

- The Main Transformer Substation;
- The Calder Transformer Substation;
- A High Voltage Transmission Line (Segment A and Segment B);
- A Transition Station;
- The Calder Switching Station ("Calder SS"); and
- An Interconnection Point to 115 kV circuit C2H owned by Hydro One Networks Inc.

The transmission line is largely contained within public right of way and some unopened road allowances that are under the control of the Crown/Ministry of Natural Resources. Some private property is required for the 115kV aboveground to underground transition station, and the Calder SS. In addition, the transmission line will cross private land along the south shore of Lower Deception Lake.

A map showing the location of the proposed facilities is included with this Notice.

NPI currently holds options for all of the land rights required for the private properties except for the Calder SS, where negotiations are ongoing. The Applicants provided forms of agreements for both an "Option to Purchase" and an "Option to Lease". The Applicant also identified 6 crossing agreements that are required with various agencies.

The Board has assigned file number **EB-2013-0047** to this application.

Board Jurisdiction

For any leave to construct application under section 92 of the Act, section 96(2) of the Act provides that when determining if a proposed work is in the public interest, the Board's jurisdiction is limited to consideration of:

- The interests of consumers with respect to prices and the reliability and quality of electricity service, and
- Where applicable and in a manner consistent with the policies of the Government of Ontario, the promotion of the use of renewable energy sources.

Environmental issues with respect to this project are considered through a separate process which is not a part of this Board proceeding.

Written Hearing

The Board intends to proceed with this matter by way of a written hearing unless a party satisfies the Board that there is a good reason for not holding a written hearing. If you object to the Board holding a written hearing in this matter, you must provide written reasons why an oral hearing is necessary. Any submissions objecting to a written hearing must be received by the Board and copied to the Applicant within **10 days** of the publication or date of service on you of this notice.

How to Participate

Comment

If you wish to give your opinion on the proceeding to the Board Members hearing the application, you are invited to send a letter of comment to the Board no later than 30 days after the publication or date of service on you of this notice. A complete copy of your letter of comment, including your name, contact information, and the content of the letter, will be provided to the Applicant and the Board Members hearing the application.

Observe

If you do not wish to actively participate in the proceeding but you do wish to receive documents issued by the Board, you may request observer status. Your written request must be received by the Board no later than **10 days** from the publication or date of service on you of this notice.

Personal Information in Letters of Comment and Observer Requests

All letters of comment and letters requesting observer status will be placed on the public record, which means that the letters can be seen at the Board's offices and will be available on the Board's website. Before placing the letters on the public record, the Board will remove any personal (i.e. not business) contact information from the letters (i.e. the address, fax number, phone number, and e-mail address of the individual). However, the name of the individual and the content of the letter will become part of the public record. Please address your letter to the Board Secretary at the address below, and reference file number **EB-2013-0047** at the top of your letter.

Intervene

If you wish to actively participate in the proceeding (e.g., submit questions, file argument), you may request intervenor status from the Board no later than **10 days** after the publication or date of service on you of this notice. 




