Other sources of background noise for the area includes traffic on the nearby Highway 6 and/or Highway 540. There is no scientific evidence of direct health effects resulting from noise at the level of noise generated by wind turbines. It has been repeatedly shown by measurements of wind turbine noise undertaken in the UK, Denmark, Germany and the USA over the past decade, and accepted by experienced noise professionals, that the levels of infrasonic noise and vibration radiated from modern, upwind configuration wind turbines are at a very low level; so low that they lie below the threshold of typical human perception, Potential health concerns/impacts as a result of the wind turbines was considered as part of the environmental screening. There are very few residences in the vicinity of the turbines. All wind turbines have been sited a minimum of 550 meters from receptors.

The REPP study is the first study to systematically analyze property values data in order to examine the charge often voiced by wind farm opponents that wind development will lower the value of property within view of the turbines. The REPP study looked at wind development projects with a generating capacity of 10 MW or more that were installed in the U.S. from 1998 to 2001. The REPP study also used much larger wind farms (up to 80 wind turbines per site) than the proposed McLean's' Mountain Farm (43 wind turbines). The REPP study found no evidence that property values decreased as a result of wind farms. Quite the contrary, for the great majority of projects the property values in the view shed of the wind farm increased at a higher rate than they did in the comparable community.
