

Notice of a Proposed Change to an Approved Renewable Energy Project

Project Description

Northland Power Solar North Burgess L.P. (“Northland”) was issued a Renewable Energy Approval on November 7, 2012, in respect of the North Burgess Solar Project (the “Project”). Information with respect to the decision on this Project can be viewed on the Environmental Registry by searching 011-5520. Northland is proposing to make a change to the Project and the Project itself is subject to the provisions of the *Environmental Protection Act (Act)* Part V.0.1 and Ontario Regulation 359/09 (Regulation). This notice must be distributed in accordance with section 32.2 of the Regulation. This notice is being distributed to make the public aware of a proposed change to the Project.

Proposed Change

Pursuant to the Act and Regulation, the Project in respect of which the Renewable Energy Approval was issued, is a 10-megawatt (MW) solar photovoltaic facility located on an approximate 75-acre parcel of land located in the Tay Valley Township in Lanark County, Ontario. An application has been made to the Ministry of the Environment, Conservation and Parks to change the project and alter the terms and conditions of the existing Renewable Energy Approval. The proposed change consists of adjusting the Project Location Boundary. This change will allow for vegetation management which will enable proper operation of the Solar PV facility, address safety of public and worker health and avoid adverse impacts such as fire and shading issues caused by vegetation growth along the southern and central sections of the perimeter fence of the facility. Both the local municipality and the Ministry of Natural Resources and Forestry have been consulted and confirmed alignment with the proposed change. If approved with this change, the total maximum name plate capacity of this facility will not be changed. The Project location, taking the proposed change into account, is specified in the map below, and further in the modification document, available at the project website listed below.
